## **BUSINESS UPDATE**

April 20, 1998 - Intrinsyc Software, Inc. The Company also announced that attendance at the Microsoft<sub>®</sub> Windows<sub>®</sub> CE<sub>®</sub> Developers Conference, held in San Jose, CA, April 5-8, that it co-sponsored, was up sharply to 2,300 end users and developers from the 800 who showed up last year and the 150 who went the year before. Unlike last years conference which focused on mobile applications for Windows CE, there was a significant OEM presence this year with an interest in general embedded applications. Intrinsyc's new products announcements were well received at this event. Microsoft promised to add hard real-time to Windows CE by mid-99, a capability that will position Windows CE as a key contender for the most critical control jobs in commercial applications.
