## **Intrinsyc Software Announces Revision to the NMI Acquisition Agreement**

**Vancouver, BC, June 21, 2004**, Intrinsyc Software International, Inc. (TSX:ICS), is pleased to announce that today it has reached agreement with the former principals of NMI Electronics Limited to complete the NMI acquisition by substantially amending the terms and conditions related to the remaining contingent and future consideration associated with the purchase of NMI in June 2002.

Based on the revised agreement, all contingent and all unpaid cash consideration as at May 28, 2004 is to be considered extinguished in return for the issuance of 4,105,727 common shares. The shares are to be issued within 14 days of today's date pending regulatory approval.

At the end of the Second Quarter, as disclosed in the quarterly financial statements and annual report, the maximum contingent consideration payable for 2004 was \$4,120,182, and the unpaid consideration related to 2003 was \$399,560. The issuance of the 4,105,727 shares satisfies all amounts payable and will complete the acquisition in its entirety.

The difference between the estimated market value of the shares at May 31, 2004 and the amount of contingent and future payable consideration accrued up to February 29, 2004 is \$442,713 and this amount has been recorded as an addition to goodwill for the quarter ended May 31, 2004.

"We are very pleased that as a result of these amendments, the transaction acquiring NMI Electronics Limited is now complete" said Vince Schiralli, President and COO of Intrinsyc Software. "This acquisition has expanded our mobility offerings and continues to be a significant contributor to Intrinsyc's current and future development plans".
